I, Manish R. Patel, Company Secretary in Practice at Surat appointed as "Scrutinizer" by the Board of Directors of H S India Limited ("the Company") to scrutinize remote e-voting as well as the e-voting by members during the 36th Annual General Meeting (AGM) of the members of the Company held on Tuesday, 9th September, 2025 at 11.30 a.m. through Video Conferencing ("VC")/Other Audio Visual Means ("OAVM") pursuant to MCA and SEBI Circulars, submit my report as under:

1. The Management of the Company is responsible for the compliance with the requirements of the Acts, Rules and Notifications and SEBI Listing Regulations relating to voting through electronic means on the businesses set out in the notice of 36th AGM of the Members of the Company. My responsibility as a scrutinizer is to scrutinize remote e-voting and e-voting conducted during the AGM in fair and transparent manner and to ascertain requisite majority and is restricted in submitting a Consolidated Scrutinizer's Report on the voting on the Resolutions set out in the Notice, based on the reports generated from the system of National Securities Depository Limited, the authorized agency to provide remote-voting facilities and e-voting facility during the AGM, engaged by the Company.
2. The AGM was convened through VC/OAVM without the physical presence of the Members in compliance with the provisions of Companies Act, 2013 and the SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015.





3. The Shareholders holding shares as on the "cut off" date i.e. 2nd September, 2025 were entitled to vote on the proposed resolutions as set out in the Notice of 36th Annual General Meeting of the Company.
4. The remote e-voting period commenced on 6th September, 2025 (9.00 am) and ended on 8th September, 2025 at (5.00 pm) and was disabled for voting thereafter.
